<ol> <li>In order to be eligible for co-option as a Drayton Bassett Parish Councillor, you must satisfy certain criteria. You must satisfy (a) and (b) below and at least one of the options (c) – (f). Please tick which apply to you:</li> </ol>
a) I am 18 years of age or over; <b>and</b> b) I am a British Citizen or a citizen of the Commonwealth or a citizen of any other member state of the European Union; <b>and</b>
c) I am registered as a local government elector for the town; <b>or</b> d) I have, during the whole of the twelve months preceding the date of my cooption occupied, as owner or tenant, land or other premises in the town; <b>or</b> e) My principal or only place of work during those twelve months has been in the town; <b>or</b> f) I have, during the whole of those twelve months resided in the town or within 3 miles of it.
2. Please note that under Section 80 of the local Government Act 1972 a person
is disqualified from being a town councillor if he/she:
<ul> <li>a) Is employed by the town council or holds paid office (other than chairman, vice chairman or deputy chairman) under the parish council (including joint boards or committees);</li> <li>b) Is employed by an entity controlled by the parish council;</li> <li>c) Is the subject of a bankruptcy restrictions order or an interim bankruptcy restrictions</li> </ul>
order or a debt relief restrictions order or an interim debt relief restrictions order; or d) Has within five years before the day of co-option, or since his/her co-option, been convicted in the UK, Channel islands or Isle of Man of any offence and has been
sentenced to imprisonment (whether suspended or not) for not less than three months without the option of a fine; or
e) Is otherwise disqualified under Part III of the Representation of the People Act 1983 (relating to corrupt or illegal electoral practices and offences relating to donations) or the Audit Commission Act 1998.
